

MOSA PRODUCER FEE SCHEDULE

The cost of certification includes Base Certification Fees, Inspection Fees and User Fees.

Inspection Fee Deposits The final cost of an inspection is the inspector's fee for service, mileage, and lodging. Any balance due will be billed following inspection, and any credit will be credited to your account or refunded upon request.

For additional annual net sales over \$2.2 million	.1%

First year processor/handler, distributor, retail or restaurant certification	\$450 per location
Update processor/handler, distributor, retail or restaurant certification	\$400 per location
Private label arrangements	\$60/hour (minimum \$200/arrangement)
